#### Composition and its Functions

**Resolution 1:**

Subject Matter 2:

Facilities for the Day scholar students who do not feel well

Resolution 2:

• It is resolved that the Day scholar students who feel sick during class hours have to go to the sick room available in the hostel. The students have to be sent with the Attender, with the Form signed by the Head of the Department. The form will be available in the hostel.

Subject Matter 3:

Code of conduct of the students during prayer time

Resolution 3:

- It is resolved that every day before the commencement of the classes, students should move to their respective classrooms at the stroke of the first bell. The classes begin every day with the universal prayer. During the prayer time, everyone in the campus should be at a standstill, observing silence.
