- 1.1 Ramps
- 1.2 Wheel chair
- 1.3. Elevator
- 1.4. Accessible washroom
- 1.5. Audio Books
- 1.6. Railings on stairs

### 2. Practising inclusion and Anti-discrimination

- 2.1 Implementation of admission policies for students with disabilities in accordance with UGC and State Government updated guidelines for admission.
- 2.2 Active functioning of the Mentoring and Counselling wing to ensure inclusive, non-discriminative atmosphere for disabled students.

### 3. Human Assistance

- 3.1 Human Assistance is rendered by student volunteers and Non-Teaching Staff to the physically challenged students for mobility between buildings.
- 3.2 Counselling Centres, Grievance Redressal Cell, Study Circle and Equal Opportunity Centre aid in rendering training and awareness programmes on the special provisions available for the disabled students in various fields

### 4. Scribe Facility

- 4.1 Scribe Facility is provided for visually challenged students at the time of both internal and external examinations.

## 5. Scholarship

5.1 Offering exclusive scholarships for students with disabilities.

## 6. Use of signage

6.1 Provision of pictogram signages such as display boards and signposts with bright colour contrast particularly helpful for persons with visual impairments.

## 7. Seating reservation

7.1 The nearest and accessible seats are reserved for the physically challenged students in bus and library to make them feel comfortable.

## 8. Learning Resources

8.1 The Library makes provisions for the disabled students to access the learning resources through special support facilities.

8.2 The Management takes initiatives to develop customized software for the disabled students to assist them in their learning process.
