## POLICY ON STUDENTS' SCHOLARSHIP AND FREESHIP

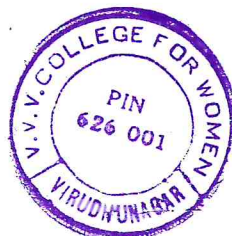

### I. Policy Statement

## PROCEDURE FOR STUDENTS' SCHOLARSHIP AND FREESHIP

### 1. Government Scholarship

The Students of Aided Programmes are facilitated with Scholarships granted under various Government schemes.

#### 1.1 Issue of Application Form and Mode of Submission

- 1.1.1 Openings for Government Scholarships will be intimated to the students through circulars via Intranet Portal.
- 1.1.2 Criteria framed by the Government are strictly adhered to.
- 1.1.3 Assistance is given by the College office to upload the application form with proper authorisation.
- 1.1.4 The College Office cannot be held responsible for the rejection of the submitted application form by the Government.

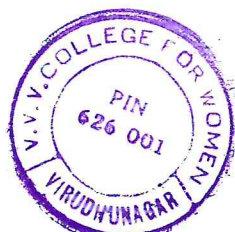
### 2. Institutional Scholarship

The Students avail financial assistance through various Institutional Scholarship schemes. The scholarships may be provided as per the need of the students covering Tuition Fee, Meal Fee, Exam Fee, Hostel Fee or any other related expenses on a genuine condition.

#### 2.1.1. Issue of Application Form and the Mode of Submission

- 2.1.1.1 Each Institutional scholarship has its own eligibility criteria.
- 2.1.1.2 Information about the Institutional scholarship along with the last date for submission is intimated through Circulars via intranet portal.
- 2.1.1.3 College office helps the students to get their respective application form for each scholarship.

- 2.1.1.4 Students submit the filled in application forms countersigned by the authorities along with the required evidences to the College office.
- 2.1.1.5 Students produce the original documents for verification whenever asked for by the concerned section in the office.
- 2.1.1.6 Institution does not respond to the late submission of the application form.
- 2.1.1.7 Scholarship is sanctioned to the deserving students who fulfil all the requirements as per the norms framed.
- 2.1.1.8 Students who do not receive any Government scholarship are given preferences.
- 2.1.1.9 Scholarship amount is credited directly to the student's bank account linked with the Institution.

### **3. Eligibility Criteria for Institutional Scholarships**

#### **3.1 V.V.Vanniaperumal College for Women Retired Teachers Kamathenu Golden Jubilee Fund**

As the crowning achievement of the golden jubilee celebrations in the year 2012 the retired Principals and all the retired faculty instituted "V.V.Vanniaperumal College for Women Retired Teachers Kamathenu Golden Jubilee Fund" to help the economically disadvantaged students of Self Finance Programmes. The Principal amount is increased by the contributions of the retired faculty members every year. Separate application form is issued to get the details of the needy students. The eligibility criteria for V.V.Vanniaperumal College for Women Retired Teachers Kamathenu Golden Jubilee Fund is as follows;

- 3.1.1 Economically disadvantaged students of UG / PG self-financing programmes.
- 3.1.2 Students with academic merits and good attendance.





### **3.2 Gurushisya**

The Teaching faculty of both Aided and Self Finance Programmes contribute liberally to the Guru-Sishya Fund either on monthly basis or annually for the cause of financially weaker section of students in the Institution. The eligibility criteria for Gurushisya are as follows;

3.2.1 Students of both the Aided and Self Finance Programmes of the college are eligible to receive the financial assistance.

3.2.2 Students' family with an annual income less than Rs.1.5 Lakhs.

3.2.3 Single parent student or a first generation learner is given priority

### **3.3 V.V.Vanniaperumal Pengal Kalloori Palayamanaviyar Sangam**

Vanniaperumal Pengal Kalloori Palayamanaviyar Sangam is a registered organization since 2017. The Department of English (Aided) generates funds in the name of Karpaga Viruksha and Ponnunjal. Cornucopia, Springs, Akshaya, Kamadhenu, Virutcham, Chem Gem are the funds generated in the Department of Commerce, History, Physics, Retired teachers, and Chemistry respectively. The generated Alumni Fund of the Departments will be sent to the registered Palayamanaviyar Sangam account. The scholarship is dispersed through the Palayamanaviyar Sangam. The eligibility criteria for V.V.Vanniaperumal Pengal Kalloori Palayamanaviyar Sangam are as follows;

3.3.1 UG / PG Students who have passed in all the IV / II semesters

## **4. Eligibility Criteria for Non-Government Scholarship**

### **4.1 Unja D. Parimala Devi - V. Dhanasamy Women's Higher Education**

#### **Trust**

Unja D. Parimala Devi-V.Dhanasamy Women's Higher Education Trust scholarship was instituted by V.Dhanasamy on 30.4.2007 with the name Unja D. Parimala Devi-V.Dhanasamy Women's Higher Education Trust. The eligibility criteria for Unjha D. Parimala Devi-V.Dhanasamy Women's Higher Education Trust are as follows;

4.1.1. Meritorious Students of Self Financing Programme



#### **4.2 Sultan Chand Dropadi Devi Memorial Scholarship Endowment**

Sultan Chand Dropadi Devi Memorial Scholarship Endowment is instituted by the Sultan Chand Publishing House, New Delhi for the award of monthly scholarship. The eligibility criteria for Sultan Chand Dropadi Devi Memorial Scholarship Endowment is as follows;

- 4.2.1 Students of all branches of Commerce in Aided and Self Finance Stream
- 4.2.2 The fund will be given to the top most academic performer of Commerce who has secured above 70% (in the I & II Year).
- 4.2.3 The value of the scholarship is divided amongst the student if more than one are eligible.

In case, the beneficiary discontinues the Programme without valid reasons it is awarded to another eligible student by merit.

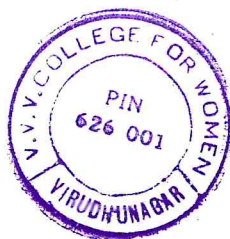
#### **4.3 Virudhunagar Hindu Nadar Abiviruthi Palasarakku Kadai Mahamai**

Virudhunagar Hindu Nadar Abiviruthi Palasarakku Kadai Mahamai scholarship instituted by the Virudhunagar Hindu Nadar Abiviruthi Palasarakku Kadai Mahamai extends financial aid to the backward class Nadar Community students. The eligibility criteria for Virudhunagar Hindu Nadar Abiviruthi Palasarakku Kadai Mahamai scholarship is as follows;

- 4.3.1 Students of Backward Class Nadar Community.
- 4.3.2 Parentless / Fatherless / Motherless students.
- 4.3.3 Economically backward and Physically Challenged Meritorious Students.

#### **4.4 K. V. R Memorial Foundation**

K.V.R Memorial Foundation scholarship supports Girls' to complete their Higher Education. The eligibility criteria for K. V. R Memorial Foundation are as follows;



- 4.4.1 Students from both Aided and Self Finance Programmes whose father is expired / abandoned by the father.
- 4.4.2 Physically challenged students of both Aided and Self Financing Programmes can also apply.
- 4.4.3 Students with poor economic status can also apply.

## **5. Eligibility Criteria for Individual Scholarships**

### **5.1 V.A.M Chidambaram Nadar - Mangayarkarasi Ammal 75<sup>th</sup> Birthday Scholarship**

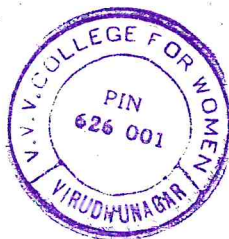
V.A.M Chidambaram Nadar - Mangayarkarasi Ammal 75<sup>th</sup> Birthday scholarship is provided to 10 needy students in the sixth semester as recommended by the Head of Department with the approval of the Principal. The eligibility criteria for V.A.M Chidambaram Nadar-Mangayarkarasi Ammal 75<sup>th</sup> Birthday Scholarship is as follows;

- 5.1.1 Students who have scored above 60% in the first 5 Semesters from both Aided and Self Financing Programmes.
- 5.1.2 Students with good conduct and attendance are given preferences.

### **5.2 Rani Sathiavan Financial Assistance**

Rani Sathiavan Financial Assistance is instituted to provide monetary aid to the economically poor students of the Department of Commerce (Aided). This scholarship is being given to the student consecutively for all the three years towards the completion of her degree as per the decision of the Head of the Department of Commerce.

- 5.2.1 Students of the Department of Commerce (Aided).
- 5.2.2 Students who have not been the recipient of any other scholarships are eligible.
- 5.2.3 Students with no arrear are given preference.





## 6. Eligibility Criteria for Scholarships from Industries

### 6.1. V.V.V & Sons Edible Oils Ltd., Scholarship

This scholarship supports Girls' to complete their Higher Education. The eligibility Criteria for V.V.V & Sons Edible Oils Ltd., Scholarship is as follows;

- 6.1 Students from both Aided and Self-financing programmes whose father is expired / abandoned by the father.
- 6.2 Physically challenged students of both Aided and Self can also apply.
- 6.3 Students with poor economic status can also apply.

## 7. FREESHIP FOR STUDENTS

### 7.1 Sports Boosting Scheme

Sports Boosting Scheme instituted by the College Managing Board encourages the sport students and promotes a healthy sports culture. Fee waiver and fee concession is offered to the students based on their level of achievement in sports.

- Fee waiver for State / National / International championship of school level.
- Fee concession for sports achievers for II year, III year and PG.

### 7.2 Noon Meal Scheme

Noon Meal Scheme generates funds with the contribution of the students, teaching and non-teaching faculty. Free lunch is provided to students of poor economic status on all working days through College canteen.

### 7.3 Termination of the Award of Scholarship / Freeship Award

The Scholarship / Freeship granted can be cancelled at any time if found incorrect / fake or against the rules and regulations stipulated by the responsible bodies.
