#### MINUTES OF THE RESEARCH ADVISORY COMMITTEE MEETING

As per the resolution passed in the meeting held on 30.09.2022 at 3.30pm in Central Instrumentation Centre, V.M.G.R.Knowledge Junction Building, the following subject matters were resolved to proceed further for promoting research activities.

Subject Matter 1:

To discuss and get approval for increasing the amount of Seed Money under VVVCMB-MRP Scheme

Following discussion was made to resolve it.

Based on the previous year Minor Research Project proposals, the Research Academia identified that a few advanced equipment were essential to accomplish the research objectives and the non-availability of some instruments in laboratories hampered the research progress. Taken into consideration of this, it was suggested that, the grant amount can be raised b the College Managing Board as per the needs of the faculty for providing conducive ecosystem. The recommendations of the Research Advisory Committee are submitted to the College Managing Board for further discussion.

Resolution

It was resolved that the College Managing Board has approved to increase the seed money from the calendar year 2023 onwards.

**Subject Matter 2:** 

1:

To discuss and get approval for the revision in seed money assistance system in VVVCMB-MRP Scheme

The following discussions were made

- The Call For Minor Research Project proposals made twice in a year will be named hereafter as Phase I (January) and Phase II ( June)
- Pertaining to the huge variations in the complexity of the scope and the grant received by the projects, there is a need to fix the tenure of the project. They are hereafter classified into Category I- seed money grant limit less than Rs.50000/- and Category IIseed money grant more than Rs.50,000/-.
- The period of the projects under Category I is one year and for Category II is one and half year.

Resolution

2: It was resolved to introduce Phase I and Phase II and Category I & II in the ensuing Call for MRP proposal.

Subject Matter 3:

To discuss and get approval for the revision in terms and conditions of VVVCMB-MRP Scheme

The following discussions were made

- The responsibilities of the Principal Investigators and Co-Investigators regarding the submission of Project Completion Report and Utilization Certificate, in case of any unforeseen circumstances, are formulated.
- The Sanction Oder copy has to be revised with detailed terms and conditions.
- The PI can extend the period of the project with prior permission and as per the suggestions of Research Advisory Committee.
- **Resolution** 3: It was resolved and approved to formulate the terms and conditions in the Sanction Order for both PI and Co-Investigators
- Subject Matter 4: To send MRP proposals to the panel of reviewers
- **Resolution** 4: It was decided to send MRP proposal to the subject experts as per the existing procedure.
- Subject Matter 5: To get approval to constitute the Research Ethics Committee
