- Resolution 1:** It was discussed and approved to increase an amount of Rs. 400 per project proposal as remuneration.
- Subject Matter 2:** To make provision of seed money to the on-going, non-releasing/partially released funded project sanctioned by ICHR and other non-government organization to initiate the project work.
- Resolution 2:** It was resolved that the seed money can be given to partially released Government projects for completing the project on-time and to initiate the project work for the applied projects under non-Government organization. The PI should refund the released amount to the account of the college after releasing the fund from Government/Non-government organization.
- Subject Matter 3:** To discuss and get approval for the issue of the Sanction Order to both the Principal Investigators and Co-investigators of the selected MRP projects under "VVVCMB-MRP Scheme 2023, Phase I.









The following discussion were made

- Terms and conditions for spending the grant under non-recurring, recurring, travel grant and contingency must be included for execution of project plan and the completion of the project on-time.
- The purchase of the items under Non-recurring Head must be

done within **30 days** from the release of the grant and the admissible 50% of the recurring grant must be spent within **60 days** of the grant being released into the account of PI.

- The PI must submit the report every six months during the project tenure.
- The Co-investigators must co-ordinate with the Principal Investigators till the submission of the Project Completion Report.

Resolution 3: It was approved to issue the Sanction Order for both the Principal Investigator and Co-investigators of the selected projects in the second week of March.
